










Figure 1. Safe Operating Area




Figure 2. Derating Curve




Figure 3. Transient Thermal Impedance




Figure 4. Pulse Power Dissipation





Figure 5. V_{CE(sat)} v I_C




Figure 6. VCE(sat) v Ic




Figure 8. V_{BE(sat)} v I_C




